Applying to be included on the North of England Weimaraner Society Judges List means you agree not to place, at any show, a blue dog purporting to be a Weimaraner. The Weimaraner Breed Standard is very clear “**The only correct colour is grey.** Silver grey preferable. Shades of mouse or roe grey are acceptable; blending to lighter shade on head and ears. Dark eel stripe frequently occurs along back. Whole coat gives an appearance of metallic sheen. Small white mark permissible on chest. White spots resulting from injuries not penalised. **Any other colour, including blue, is highly undesirable.**” Any other coat colour is considered ‘Colour not recognised by The Kennel Club’ and should be considered a serious fault.

Any judge on the NEWS Judges List who is found to have placed a blue dog will be removed from the List with immediate effect
